1. **About Netherlands¹**

The Netherlands is situated in northwestern part of Europe facing the North Sea, bordering Belgium and Germany, and has a geographical area of approximately 33,893 sq km of land and 7,650 sq km of territorial water.

The Netherlands is one of the founding members of the European Union, the OECD and the World Trade Organization. According to the World Bank and the International Monetary Fund, it is the seventeenth-largest economy in the world and sixth-largest economy in the European Union. The country acts as a European transportation hub with strong logistics and technology infrastructure support which contributes to a high trade surplus, stable industrial relations, and low unemployment.

Agriculture is the key sector for Netherlands and employs around 2% of the labour force. Other key sectors include chemicals, petroleum refining, electrical machinery, technology, and financial services.

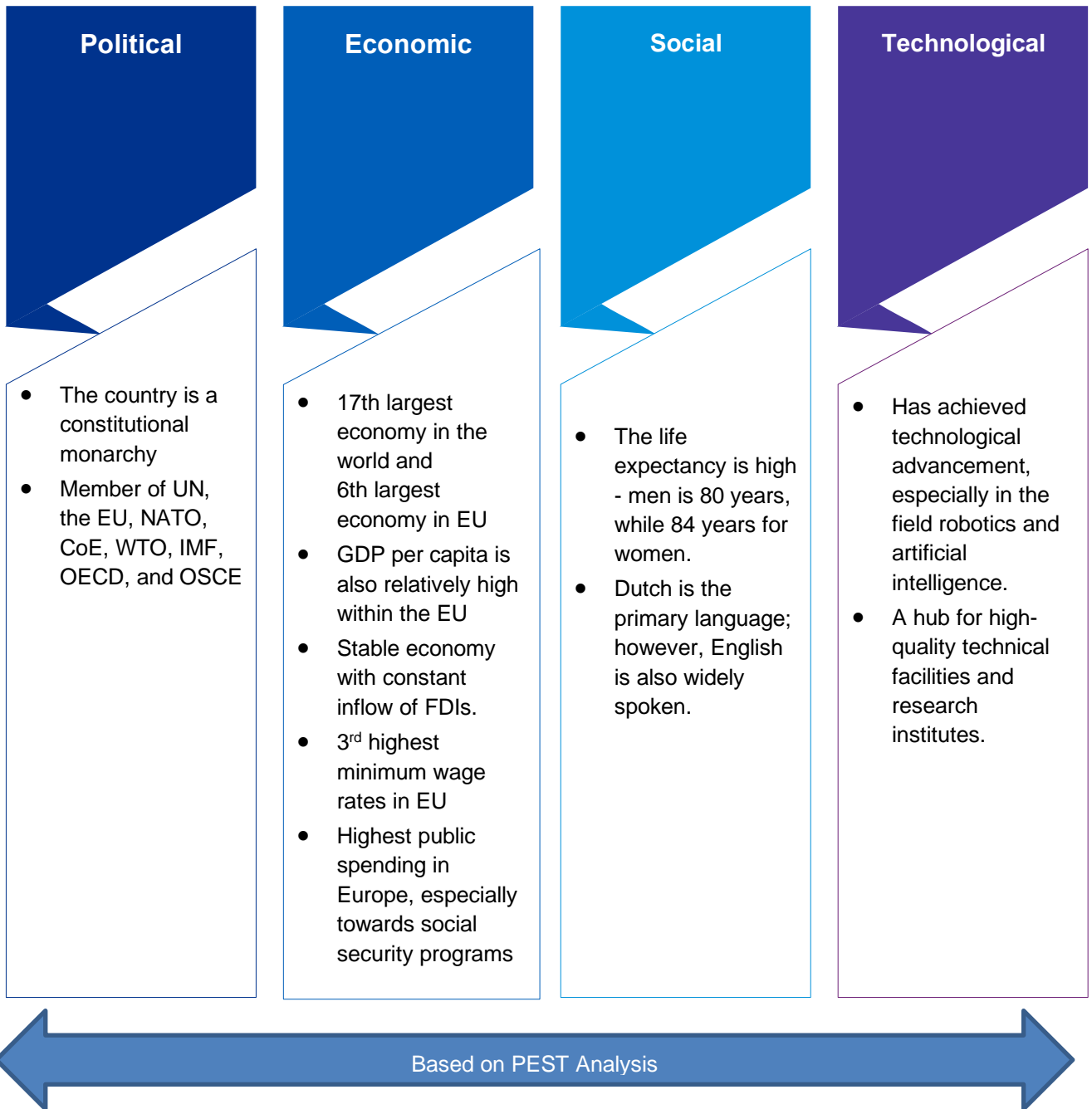

2. India - Netherlands Relations

Trade and commercial relations constitute the bedrock of bilateral ties between the two countries - Netherlands is the fourth largest foreign investor in India and has invested about USD 39,302 million between April, 2000 to December, 2021. The top five sectors attracting FDI equity flows from the Netherlands are services sector, computer software and hardware, trading, automobile industry and fermentation industries

India also has strong economic interests in the Netherlands and is the nation's 27th largest trading partner. There is a large Indian economic presence in the country as well, with over 200 Indian companies operating within.

India is Netherlands 27th largest trading partner. Despite the disruptions during Covid-19, Indian exports to Netherlands have grown from USD 3155.6 mn.(2016) to USD 3701 mn. (2020) at a CAGR of 4.1%.

- Prime Minister Mark Rutte visited India in June 2015. He was accompanied by the Minister for Foreign Trade and Development Cooperation Ms. Lilianne Ploumen, the Minister for Agriculture Ms. Sharon Dijksma, as well as representatives from 100 Dutch companies
- PM of India visited to the Netherlands in June 2017 provided a significant boost to India-Netherlands bilateral cooperation
- External Affairs Minister (EAM) visited the Netherlands during November 9 -11, 2019

3. Karnataka Netherlands Relations

During 2016 to 2020, Karnataka's exports to Netherlands have increased from USD 268 mn. to USD 316 mn. Despite the disruptions during Covid-19, Karnataka's exports to Netherlands have grown by 4.1 per cent. The State's top 10 products contribute to 91.8% in its total exports to Netherlands.

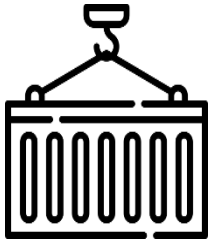
